

**REQUIREMENTS FOR APPLICATION FOR ISSUE OF A VISA TO TRAVEL TO
FIJI FOR VISIT/HOLIDAY PURPOSE ONLY**

1. Complete visa application form.
2. Two (2) recent passport photographs – coloured/black & white.
3. Fee of **NZ\$105.00** per person, in Bank Cheque payable to the “Fiji High Commission.” Personal cheques not accepted.
4. A passport valid for at least six (6) months beyond the intended stay in Fiji, i.e if intended stay is for a month, the validity of passport required will be four months etc, and a return/onward ticket.
5. A copy of the itinerary or travel details from the airline.
6. Visa for the next country of destination after Fiji. (Visa for the next country of destination must have minimum six (6) months validity).
7. Prepaid courier bag or self-addressed stamped envelope for return of passport/visa.

8. Allow thirty (30) working days for processing.
9. All passports are returned by courier unless otherwise instructed.
10. Persons travelling to Fiji without proper visas will be refused entry, unless a National of a visa exempt country as appearing in this note.
11. Incomplete or incorrect applications will be returned.
12. If sponsored by a Fiji national, please include sponsorship letter.

Vaccinations: Not required for Fiji.

National Holidays: National Youth Day, Good Friday, Easter Monday, Ratu Sir Lala Sukuna Day, Queen's Birthday, Prophet Mohammed's Birthday, Constitution Day, Fiji Day, Diwali, Christmas Day, Boxing Day.

Climate: There is a mild dry season from May to October with a warm, damp season from November to April.
